ORDER GRANTING APPLICATION FOR APPOINTMENT OF RECEIVER

Petitioner MAURIZIO CORDOVA's Motion and Application for Receiver of MEDINAH MINERALS, INC. having been considered by the Court, the Court having considered the pleadings and papers on file herein, with no opposition being filed, and for good cause appearing therefore:

THE COURT HEREBY FINDS that: MAURIZIO CORDOVA's application for Appointment of Receiver filed on November 3, 2025 seeking the Court's intervention under NRS 78 for an appointment of a receiver to take charge of the assets and liabilities of MEDINAH MINERALS, INC. is well founded and meets the requirements of NRS 78.630.

THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

23 1. Pursuant to NRS 78.635, Pub Sec AI LLC is hereby appointed receiver of MEDINAH
24 MINERALS, INC.

25 2. Pub Sec AI LLC shall have the powers permitted by NRS 78.635 including the right:

26 (a) To demand, sue for, collect, receive and take into possession all the goods and
27 chattels, rights and credits, moneys and effects, lands and tenements, books, papers,
28 choses in action, bills, notes and property, of every description of the corporation;

1 (b) To institute suits at law or in equity for the recovery of any estate, property,
2 damages or demands existing in favor of the corporation;

3 (c) In their discretion to compound and settle with any debtor or creditor of the
4 corporation, or with persons having possession of its property or in any way
5 responsible at law or in equity to the corporation at the time of its insolvency or
6 suspension of business, or afterwards, upon such terms and in such manner as they
7 shall deem just and beneficial to the corporation; and

8 (d) In case of mutual dealings between the corporation and any person to allow just
9 setoffs in favor of such person in all cases in which the same ought to be allowed
10 according to law and equity.

11 3. Pub Sec AI LLC is permitted to require proofs of claim pursuant to NRS 78.675 and
12 will provide notice to MEDINAH MINERALS, INC.'s potential creditors and
13 claimants of their obligation to file a timely proof of claim.

14 a. For creditors who are unknown to the Receiver and cannot, after due diligence,
15 be found, the receiver shall be permitted to serve these parties by publication.
16 Service by publication must occur by publishing notice at least once a week for a
17 period of 4 consecutive weeks in the Nevada Legal News, which is a newspaper
18 of general circulation published in Clark County, Nevada. Service by publication
19 is complete four weeks from the later of: (i) the date of the first publication; or
20 (ii) the mailing of notice of the entry of order directing claims, whichever is later.

21 b. MEDINAH MINERALS, INC.'s potential creditors and claimants shall submit
22 written claims under oath to Pub Sec AI LLC as Receiver of MEDINAH
23 MINERALS, INC. within 30 days of the Notice of Entry of this Court's Order on
24 the instant motion.

25 c. Pub Sec AI LLC will respond in writing to all timely submitted claims to
26 determine the validity of debt or claims for conversion of shares while affording
27 any claimant dissatisfied with the response to appeal the decision to this Court.
28 See NRS 78.685(1).

1 4. Pub Sec AI LLC shall provide reports to the court on the progress of the receivership,
2 advising of the actions taken, including accounting for the disbursement of any funds
3 every ninety (90) days.
